Dear Members and Friends

#### A GLIMPSE INTO THE PAST

Applewood Valley Methodist Church had its beginnings in the summer of 1956. At that time The Reverend William R. Griffiths first visited the area and made a canvass of potential members. The first services were held in a recreation building in Prospect Park, 44th and Youngfield. After several meetings there the group met at the Maple Grove School. Shortly thereafter services were moved to the Maple Grove Grange.

Formal organization of the church took place on March 31, 1957. The charter membership was formally established a short time later with 102 members signing the official scroll.

The first parcel of land purchased was a 2½-acre site at 28th and Youngfield, the deed being signed June, 1957. During August, 1958, a contract was signed for the first unit and construction commenced. However, on September 25, 1958, the State Highway Department advised of plans to build Interstate 70 across the property and in November, 1958, the land (and a hole in the ground) was sold to the State Highway Department.

Search for a new site commenced immediately and was successfully consummated in February of 1959 when the present 6-acre site at W. 20th Avenue and Ellis was purchased.

The first unit was commenced with ground breaking ceremonies April 18, 1959, the building being consecrated the following November 15th.

The parsonage was completed in July, 1961, and The Reverend Zeke Jumper, successor to Reverend Griffiths, was its first occupant. In October, 1962, Reverend Jumper was compelled to retire because of ill health (he died February 5, 1965) and the Reverend James E. Barnes became the pastor. In the  $5\frac{1}{2}$  years Reverend Barnes has served the church, the membership has grown from 272 to 1,085.

Almost from the very beginning of Applewood Valley Methodist Church a Building Committee has been in existence. Always in the planning of church construction it was the very wise policy of the committee to work toward an overall plan with each step complete in itself, yet so designed as to fit into the entire plan harmoniously.

In March, 1963, construction was started on additional educational facilities and these were completed the following September.

The building committee next engaged in the planning of the third and final unit—the sanctuary and additional educational facilities, together with a fellowship hall and kitchen.

The drawings of Architect W. Patrick Dulaney were accepted and the low bidder, Cyrus G. De Lano, was awarded the contract. Ground-breaking ceremonies were held on Sunday, July 2, 1967. On March 31, 1968, the eleventh anniversary of the formal organization of Applewood Valley Methodist Church, the congregation worshiped for the first time in the new Church at 9:30 a.m. and 11:00 a.m. services.

On Palm Sunday, April 7, 1968, Bishop R. Marvin Stuart of the Rocky Mountain Conference, assisted by The Reverend William O. Byrd, Superintendent of the Denver District, conducted the Consecration service in the new church.

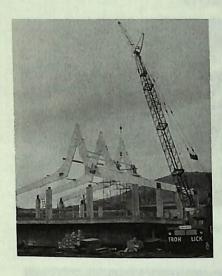

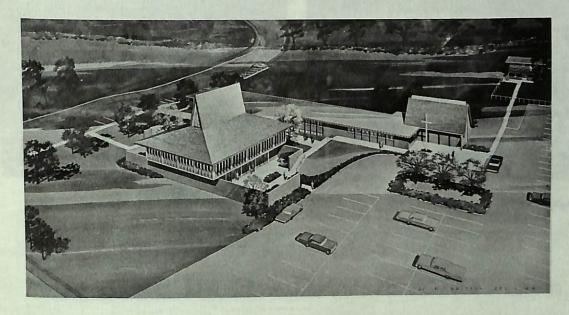

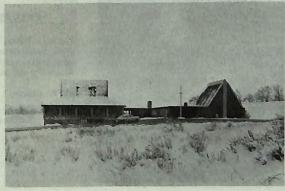

Dear Members and Friends of Applewood Valley United Methodist Church

Beginning June 1, 1968, we enter upon a new Church year. This brochure has been designed with the purpose in mind of trying to answer the questions most people ask about our church. Some are answered in pictures, some in words, and some in figures. Let me talk with you a moment about the figures.

As you will see, the budget for the new church year has been itemized in detail within the three major categories: Operating Expenses, Benevolences, and Building Fund. Methodists are aware that the items in the Benevolence budget are Conference apportionments, requests for funds from each local church to support benevolence projects approved at each Annual session of the Rocky Mountain Conference. We have included Reverend Al Brown's salary in this category because his work in the Core City is our church in mission.

Having reviewed the budget your next question will be: "What shall I give?" The National Council of Churches has just announced that the typical American Protestant contributes \$2.44 a week to his church. What this actually says however is that some members tithe, while a large number still believe that a church can operate on a \$1 a member. You may be interested in the weekly giving pattern of 283 identifiable givers in our church, for the period October, 1967, through February, 1968.

Based on receipts as of April 1, 1968, our people are supporting the current budget at the rate of \$77,180 a year. This is exclusive of \$5,214 in memorials as of April 1, but includes the generous special gifts received on Opening Day in the new sanctuary.

The Official Board has approved a tentative budget of \$98,572 for fiscal year beginning June 1, 1968. This is a 22% increase over the current regular pattern of giving and necessarily takes into account limited experience data on the cost of operating the new church and educational wing. However, we believe that the new budget is sound.

It is no secret to anyone that regular weekly giving is of utmost importance in meeting our obligations. But how much? You alone can answer that. However, is it unreasonable to ask that you consider as your goal for the coming year an amount each week equivalent to \$1 for each \$1,000 of income—half a tithe? We are aware that many have given and will continue to give more. Others, due to circumstances, must limit their gifts. This is proportionate giving—in proportion to the measure of our material blessings. Is that not a true definition of tithing?

Details of Loyalty Sunday should have reached you earlier. A Pledge Card is enclosed. The decision is yours. Thank you for vows fulfilled: Your prayers, your presence at worship, your gifts, and your service. With these, and God's blessings, how can we possibly fail?
